일반 산림 현황

솔로몬의 산림은 총 2,185,000 ha 로 전체 국토면적의 78.1%를 차지하고 있습니다.¹⁾ 산림면적은 원시림(Primary), 기타천연갱신림(Other naturally regenerated), 조림지(Planted)로 구분할 수 있으며 각 면적은 다음과 같습니다.²⁾

- 원시림(Primary) : 1,105,000 ha(50.6%)
- 기타 천연갱신림(Other naturally regenerated) : 1,053,000 ha(48.2%)
- 식재림/조림지(Planted) : 27,000 ha(1.2%)

벌채 허가 관련 사항

솔로몬 내에서의 벌채는 일반적으로 전기톱을 이용하는 벌채로 진행되며 수작업에서 중장비를 활용한 산림활동까지 다양합니다.

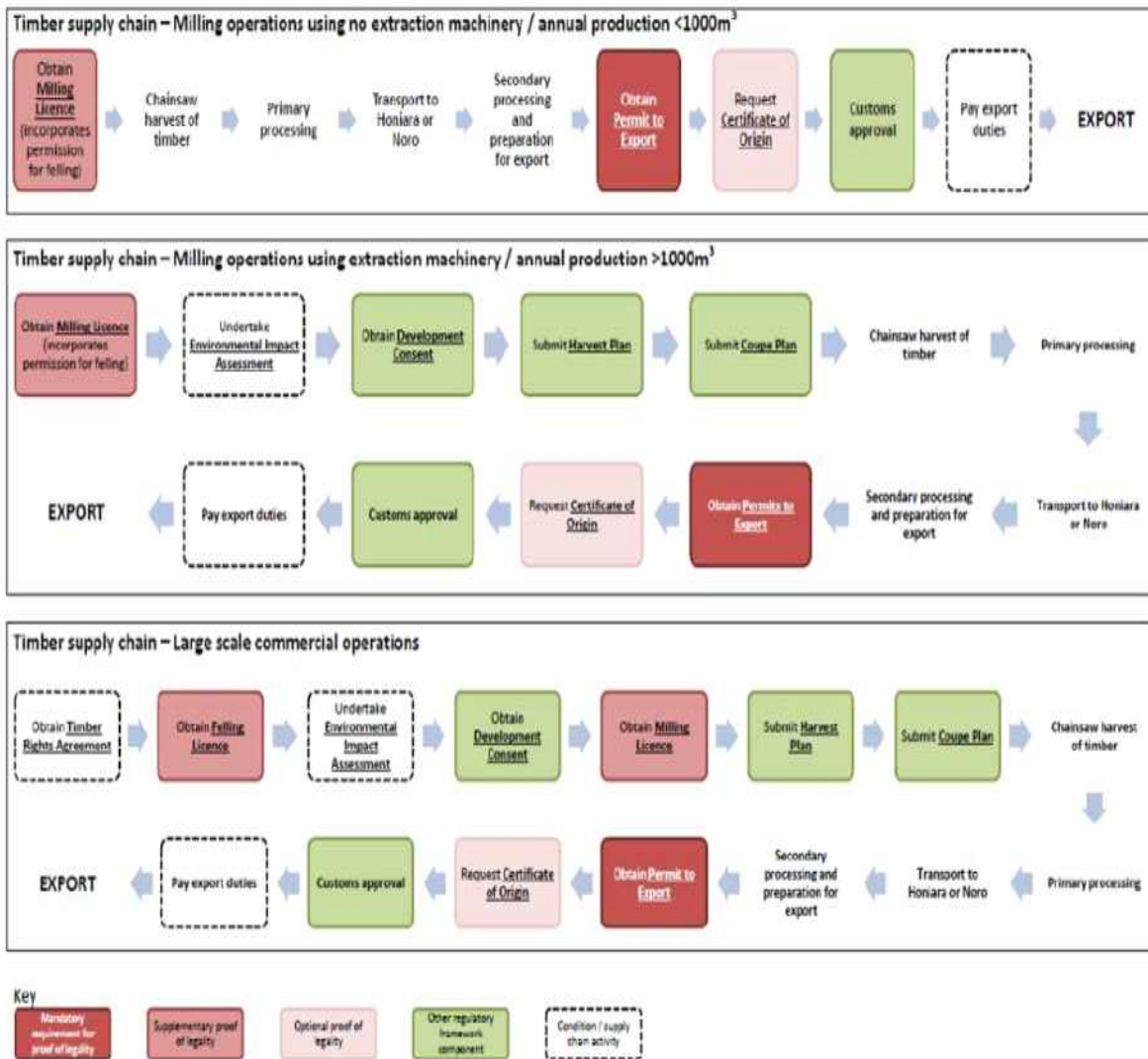


그림 51. 제재목 공급망⁹⁾

솔로몬에서 목재제품을 수출하기 위해 수출업자는 산림부(Ministry of Forestry and Research)에서 수출허가서(Permit to Export)를 발급받아야 합니다. 수출허가서를 신청하기 위하여 허가서 번호, 수출량, 수종, 수출액 등 교역과 관련된 세부사항을 기재하여야 합니다. 수출허가서를 신청할 때에는 다음의 필수서류가 첨부되어야 합니다.¹³⁾

- 수출되는 목재의 수종, 물량을 식별할 수 있는 거래명세서(Packing list)
- 구입주문서(Purchase order), 송장(Invoice) 등 거래 증빙서류
